

THE BENEFITS OF MEMBERSHIP

MUNICIPAL LEVEL

- You have the title of clerk, treasurer, finance officer or a combination of the three.
- You are elected or appointed by your municipality.
- Education and experience requirements are set by the municipality.

STATE LEVEL

THE OKLAHOMA MUNICIPAL LEAGUE (OML)

- Administers the State Training Certification as required by statute.
- The certification requires an annual \$50 fee in addition to attendance at one qualified training.
- In addition to the training, the fee also covers the cost of the "Handbook for Oklahoma Municipal Clerks, Treasurers & Finance Officers" and periodic updates.
